TO CALCULATE PRODUCT DENSITY:

1. Multiply length x width x height of product package in inches to obtain the package volume in cubic inches.
2. Divide the volume by 1,728 (inches to cubic foot) to obtain the package volume in cubic feet.
3. Divide the gross weight (lbs.) of the package by the cubic feet of the package, as obtained above to determine the lbs. per cubic foot or density.

We reserve the right to rate any commodity where we deem it necessary to do so because of the density of the product or any other applicable reasons.

To facilitate service on truck loads inbound and/or outbound, avoid delay by calling Shipping/Receiving for an appointment.

SERVICE CHARGES

1. WAREHOUSE HOURS:

Shipping: 6:00 a.m. to 6:00 p.m. Monday through Friday
Receiving 6:00 a.m. to 2:00 p.m. Monday through Friday
Customer service: 7:00 a.m. to 5:00 p.m. Monday through Friday

2. RECEIVING AND DELIVERING OUTSIDE OF REGULAR WAREHOUSE HOURS:

Monday through Friday \$244.73 per hour. Saturday, Sunday, and holidays are subject to special arrangements in advance. \$244.73 per hour (minimum of 4 hours) in addition to warehouseman labor rate. Regular warehouse labor rate: \$73.42 per man hour; Supervisor rate: \$104.01 per man hour.

3. EXTRA SERVICE:

The following services are not included in the regular tariff charges: USDA Import & Export Services, Trichinae Certification, Repacking, Rehandling, Weighing and Recording Weights, Restrapping, Physical Inventories, Special Clerical Services, and all extra services not provided in this schedule of rates. Rates for these services will be provided upon request.

4. SORTING BY CLASS, GRADE, OR SIZE ON RECEIPT:

Will be charged for all lots and quantities; 2-5 lots \$.73, 6-10 lots \$.88, 11-15 lots \$1.35, 16-20 lots \$1.58, 21 or more \$1.99 per cwt. gross wgt.

5. STRETCH WRAP CHARGE:

A service fee of \$6.45 will be charged for product requiring wrapping from top to bottom as part of the inbound or outbound process as needed. Other materials such as corner boards, separators, etc. will be supplied upon request for an additional fee.

6. DELIVERY CHARGE/LOT RELEASE CHARGE:

A charge of \$6.12 will be made for a delivery from any warehouse lot per consignee.

7. CANCELLED/MODIFIED ORDER:

An administrative fee of \$35.64 per order will be applied to all orders that are cancelled/modified by the customer. In the event the order has been preselected and staged for shipment, extra handling charges will be applied per the tariff to be returned to the appropriate lot in storage.

8. TRANSFER CHARGE:

A charge of \$15.02 will be made to transfer each lot or part of a lot transferred.

9. CONTAINER UNLOADING:

A charge of \$1.00 cwt. gross will apply when unloading containers, \$305.91 minimum.

10. LOADING CONTAINERS FOR EXPORT SHIPMENT:

\$2.17 cwt. gross, \$389.34 minimum. Subject to arrangements in advance.

11. TRUCK LOADING/UNLOADING:

A charge of \$9.27 per pallet will be applied for straight loading or unloading palletized cargo.

12. TAKING AND REPORTING MARKED WEIGHTS ON RECEIPT OR DELIVERY:

\$.89 per package. Minimum charge of \$35.64 per bill of lading.

13. MINIMUM LOT CHARGES:

Minimum handling charge per lot: \$25.59

Minimum storage charge per lot: \$25.59

Minimum renewal storage charge per lot: \$26.86

Minimum long term storage charge per lot: \$28.20

Minimum extended storage charge per lot: \$31.04

14. MAKING COLLECTIONS:

Receiving check - \$50.06 per transaction

Receiving cash - \$83.43 per transaction

15. INVENTORY REPORT:

\$38.93 each

16. OVERNIGHT SAMPLE SHIPMENT:

Made via FedEx, Airborne, UPS, etc. is \$133.49 per box. This includes insulated box, packing of product and dry ice. All freight charges will be the responsibility of the shipper.

17. PRODUCT INSPECTIONS:

Applicable handling charge by products and weight category. Minimum charge per lot inspected \$25.00.

18. TEMPERATURE REDUCTION CHARGE:

A charge of \$1.95 per cwt. gross (minimum of \$361.53 per lot) will apply to all freezer storage product received at a temperature of 16 to 24 degrees Fahrenheit and to all cooler storage product received at a temperature of

50 to 75 degrees Fahrenheit.

19. FREEZING CHARGE:

A charge of \$2.50 per cwt. gross (minimum of \$361.53 per lot) will apply to all product received above 24 degrees Fahrenheit.

20. DIGITAL PHOTOS:

A charge of \$35.64 will apply for up to ten (10) images per lot.

Additional photos will be rated upon request.

21. INSERT/REMOVAL OF DIVIDERS:

A charge of \$.85/cwt (minimum of \$165.00 per lot) will be applied

22. ASN Labels:

A charge of \$4.00 per label applied to pallet
